Please consult the AKC Regulations for Agility Trials for a complete description and eligibility for entry into these classes. The exhibitor is fully responsible for entering the dog in the correct class(es)/height divisions. Dogs running in a lower height division than they are eligible for will be eliminated.

DOG ELIGIBLE TO ENTER

This trial is open to all dogs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), an AKC Canine Partners listing number, or approved Foundation Stock Service (FSS) breeds are eligible to participate.

Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Wherever the word "dog" is used in these regulations it includes both sexes.

Dogs should be physically sound. Dogs that are blind shall not be eligible, and neither are bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect the dog's physical or mental performance. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes

MEASURING and HEIGHT CARD INFORMATION

All dogs competing in agility must possess an official AKC Jump Height Card. Dogs without a valid Jump Height Card/Form may still compete; but they must be measured by the **Judge of Record** PRIOR to running in their class and this measurement will be valid for that weekend of trials only. Except for 2021, where only VMO's or Agility Field Reps will be measuring, if present. The exception to this requirement is a dog entered in the 24" or 26" height division. However, if a **Volunteer Measuring Official (VMO)** or an **Agility Field Rep** is present; **ALL** dogs without a valid Jump Height Card/Form must be measured at some time during the trial or cluster of trials. This does not preclude having the dog measured by the Judge of Record if the VMO or Rep is not available to measure the dog *before* its first run of the trial or cluster of trials. It is the exhibitor's responsibility to have their dog measured prior to running and failure to do so will result in the cancellation of any qualifying scores.

When filling out the entry form, there is a section at the top of the form for exhibitors to designate whether your dog needs to be officially measured. Please check the box so that the Trial Secretary knows whether to include your dog on the *Dogs To Be Measured List*.

Our Judge is not a VMO. There will be no measuring at this trial.

No entry shall be made and no entry shall be accepted which specifies any conditions as to its acceptance. **Illegal entries** will not be processed and will be returned to the exhibitor.

Returned checks do not constitute a valid entry. Returned checks will be charged a \$25 collection fee added to the amount of each returned check.

ONLINE ENTRIES: This trial does accept online entries through AKC Online Entry (www.akc.org). During the first 48 hours after opening, the initial limit of entries will be designated as follows: Online entries 120; Paper entries 230. If either form of entry has not filled at the end of the 48 hour time period, the club reserves the right to decrease or increase either the online or paper limits accordingly. No hand deliveries will be accepted in the first twenty-four hours following the opening date and time.

CATALOGS

Advance catalog sales may be ordered and prepaid on your entry form for \$10. A limited number of catalogs will be available for sale at the trial site for a cost of \$15.

MOVE-UPS

Move-ups as a result of titles earned after entries close must be submitted in writing or email so that Heather (Trial Secretary) receives them by **6:00 PM PDT on Monday, May 31, 2021**. Include dog's call name, owner's name, class you are moving from, and class you are moving to (replying to your final CONFIRMATION EMAIL is an ideal way to complete a move-up). If you do not receive an acknowledgement of your move-up request within 24 hours of sending, please contact Heather to make sure that it was received. No phone move ups accepted. Day-to-day move-ups will be accepted at the trial.

The Regulations now allow exhibitors who have entered a class for which the dog or handler is not eligible to change their entry to the class for which they are eligible, but the request for such a change must be in writing and must be submitted to the Trial Secretary at least 30 minutes prior to the start of the Trial.

Move-ups for Saturday and Sunday must be submitted in writing no later than 30 minutes after the conclusion of the last class on Friday and/or Saturday. For allowed changes from Novice A to Novice B, refer to Chapter 1, Section 21 of the Regulations for Agility Trials.

NOTICE TO EXHIBITORS

REFUNDS

100% of entry fees will be refunded for any reason if written (or email) request is received by the trial secretary on or before closing.

No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee.

Bitches in season are not permitted to compete in Agility Trials. As such, the club will refund all entry fees for bitches unable to compete for this reason. Notification must be received by the Secretary prior to the start of judging on the first day of the trial or cluster of trials.

Sick or injured dogs, sick or injured handlers will receive a refund of entry fees less \$5.00 per run/day if written (e-mail) notification is received by the Trial Secretary 30 minutes prior to the start of the trial.

Returned checks do not constitute a valid entry. Returned checks will be charged a \$25 collection fee added to the amount of each returned check.

Change of judge: If the judging assignment changes after the distribution of the premium list, an exhibitor has the right to request a full refund of their entry fees for any class affected. Exhibitors must submit requests in writing to the Trial Secretary a minimum of 30 minutes preceding the start of the event on the first day the exhibitor is entered.

Refreshments

We will not be providing refreshments or lunch at these trials. Please bring your own lunch, snacks and water.

Vendor Information

Unfortunately, due to COVID-19 restrictions, we are not able to have vendors at these trials.

SAFETY, BEHAVIOR and LIABILITY

The safety of the dog is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. The Greater Spokane Shetland Sheepdog Club, the Trial Secretary and Spokane County Fair and Expo and its agents, employees, etc., will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children. The GSSSC reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against the GSSSC or any official thereof.

RINGSIDE

Dogs may arrive any time prior to judging if the dog has a valid temporary or permanent jump height card. Otherwise, they must be available for measuring prior to the start of their class if a VMO or AKC Field Rep is available to measure dogs. All dogs not needed for further judging will be excused.

Judges are not required to wait for dogs. The Owner of each dog is solely responsible for having it ready at ringside when it is to be judged. The Club has no responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

DO NOT LEAVE ANIMALS UNATTENDED IN VEHICLES. The club will not be responsible for damage to vehicles resulting from the rescue of animals in distress.

This club does not agree to arbitrate claims as set forth on the Official AKC Entry Form for this event.

VOLUNTEERS

THANK YOU, THANK YOU, THANK YOU. White boards will be set-up outside of the ring if you have some spare time. Volunteers will receive a \$2.00 voucher for each class worked. These vouchers may be used for future entry fees for Trials held by GSSSC.

RIBBONS, AWARDS, AND PRIZES

Ribbons will be awarded in each jump height division in each class as follows:

First Place.....	Blue

A New Title rosette will be awarded to all dog and handler teams finishing a title. A MACH/PACH rosette and decorated MACH/PACH bar will be awarded to all dog and handler teams that attain their MACH/PACH. PAX Title Rosettes will be awarded to all dog and handler teams finishing their PAX title. If you are close to earning an award, please let the [Trial Chair or Trial Secretary](#) know so that the club is prepared to celebrate with you.

CLASS CHANGES EFFECTIVE JANUARY 1, 2020

ENTERING A MIXTURE OF REGULAR AND PREFERRED CLASSES WITHIN THE SAME TRIAL WEEKEND – Multiple Jump Heights Within the Same Trial Day

Effective January 1, 2020, exhibitors may enter a mixture of both Regular and Preferred classes on the same trial day and/or during a trial weekend. Any mixture of Regular and Preferred classes is allowed. Please note that if a dog qualifies in Regular Master Standard and Preferred Master JWW (or vice versa) on the same trial day, then NO Double Q shall be earned toward either the MACH or PACH title. The Double Q still requires that Standard Agility and Jumpers With Weaves be either both Regular OR both Preferred on the same trial day.

Additionally, within the same Regular or Preferred classes, a dog may now be entered in multiple jump heights within the same trial day. For example, the same dog may now be entered in 20-inch Master STD/JWW while also entered in 24C-inch Premier STD/JWW on the same trial day.

A separate entry form must be submitted when the same dog is being entered in a mixture of Regular and Preferred and/or different jump heights within the same trial weekend thereby clearly indicating which class(es) and/or jump heights belong together for each trial day of the weekend.

ENTERING FOR EXHIBITION ONLY (FEO)

As of January 1, 2020, For Exhibition Only may be offered at the option of the host club. FEO will allow exhibitors to work with their dogs in a trial environment. FEO is only allowed in the Time 2 Beat and FAST classes. FEO will be of value to new exhibitors or exhibitors that are having difficulty with a specific obstacle and/or ring environment. Competitors must enter in T2B and/or FAST. Participation in FEO is non-qualifying.

- FEO runs are treated as trial entries. The exhibitor must enter the class(es) (T2B and/or FAST) prior to the closing date, pay class entry fee(s) and the Trial Secretary must record the entry in the Trial Catalog as part of the results for that class. FEO does not need to be noted on the entry form; the handler will declare the day of the show.
- Dogs may be entered in any jump height for FEO runs. If entered in an ineligible jump height, the team is committed to FEO for that run and must declare FEO on the start line. Day of show jump height changes are not allowed.
- Dogs may be entered in any level of FAST (Novice, Open, Excellent, Master). If the dog is not eligible for the level entered, the team is committed to FEO for that run and must declare FEO on the start line. Day of show level changes are not allowed.
- The exhibitor must declare FEO in the ring prior to leading out. FEO may be declared earlier (ex. when checking in at the gate board).
- Toys are allowed in the ring
 - Toys must be non-audible
 - Toys may not leave the handler's hand
 - Toys that roll freely cannot be used
- Food/treats are not allowed in the ring
- FEO should be utilized for the benefit of the dog and not as a punitive correction. Harsh verbal and/or physical corrections shall not be tolerated. Any determination of harshness by the judge shall be immediately whistled and the handler will be dismissed from the ring.
- A judge must monitor the entire run. Judges can stop a run at any time

FIX AND GO ON (FNG)

As of January 1, 2020, Fix and Go On will be offered. FNG allows exhibitors to immediately reattempt an obstacle at any time while on course when the dog's performance of an obstacle is not to their expectation. This allows the dog to successfully complete the obstacle then finish the course or leave the ring on a positive note. Using FNG will result in a non-qualifying score.

Fix and Go On is not pre-entered; rather, it occurs during the course of the run.

COURSE WALK-THROUGHS AND WARM-UP INFORMATION

Course maps will be posted, and exhibitor copies will be emailed the night before.. Judge's briefing and course walk-throughs will occur prior to each class except excellent-masters. Handlers in all classes are permitted to walk the course, without a dog, during a walk-through period held prior to the start of the class. The walk-through is restricted to handlers entered in that class only. Injured handlers may walk with their substitute handler. Handlers with multiple dogs, at events with multiple rings may request to walk with a height group other than the one their dog is entered in if a conflict is imminent.

A warm-up area, consisting of a regulation agility jump, may be provided for exhibitors. The warm-up area is to be used exclusively for warming up the dog and not for training or relieving of the dog.

COVID-19 CONCERNS

PLEASE READ CAREFULLY THE INFORMATION BELOW, AND THE WAIVER STATEMENT ON THE ADJACENT PAGE.

In order to comply with guidelines for reducing the spread of COVID-19, a number of normal trial procedures will be modified. **If Spokane County is still in Phase 2 at the time of these trials, we are required to comply with the Phase 2 Agricultural Events COVID-19 Requirements issued by the WA Governor's Office on August 10.** "Companion animal shows" are included among the events to which these regulations apply. Among the applicable regulations are the following:

Participants are required to use cloth face coverings at a minimum. All staff and any participants are required to stay home if they are sick. Access is limited to only necessary participants – NO spectators, vendors, guests or visitors. Participants that are minors may be accompanied by one adult.

Events must allow for social distancing and avoid high densities of people. For our events, this means separate entrance and exit locations, smaller walk-through groups, measures to maintain distance between handlers while waiting to go into the ring, and restrictions on the number and locations of people in proximity to the ring.

Procedures for worker signups, gate check-in, judge's briefings, course maps, results posting, ribbons, and stickers will also be modified to encourage separation of people, and to reduce as much as possible the handling of materials by multiple people.

Events held indoors are limited to 50% capacity or up to 50 participants at any one time (not including staff), whichever is less. It may be necessary to restrict access to the building in order to comply with this requirement.

Any person present at the trials that is not an exhibitor, whether working or not, will be required to sign a COVID waiver form prior to (preferred) or when arriving at the event.

DIRECTIONS TO THE TRIAL SITE

DRIVING DIRECTIONS TO SPOKANE COUNTY FAIR AND EXPO CENTER, 404 N Havana, Spokane, WA 99202:

Coming from the west (Seattle/Spokane), take I-90 to the Freya exit (#283B) which merges with 3rd Avenue. Continue on 3rd to Havana St. Turn LEFT on Havana, and go 0.7 mile, crossing Sprague Avenue (traffic light) and continuing past the main Fairgrounds entrance to Broadway. Turn RIGHT on Broadway, go 0.5 mile and turn RIGHT into the Fairgrounds at Gate R.

Coming from the east (Idaho/Montana), take I-90 to the Broadway exit (#286) and turn RIGHT off the exit ramp onto Broadway. Continue for 1.0 mile on Broadway, crossing Fancher (traffic light), and then turn LEFT into the Fairgrounds at Gate R.

ADDITIONAL SITE INFORMATION

SITE: Spokane County Fair and Expo Center, 404 N. Havana St., Spokane, WA 99202

These Agility Trials will be held indoors on dirt. The ring is 100' x 100'. The ring will be fenced with a combination of wood panels and portable fencing, with gates for entry to ring. Restroom facilities are on site. Crating will be indoors on dirt and concrete.

Of course, we know everyone will uphold the *great reputation of agility exhibitors* by cleaning up after your dogs at the fairgrounds and your motel!

VENDORS

No vendors will be present for this trial.

FOOD AT THE TRIAL: No food will be supplied for this trial.

Obstacles will meet the specifications for obstacles in the current edition of the Regulations for Agility Trials. All classes will take place indoors on a packed dirt surface.

Overnight RV Parking

2. There are a few frost-free faucets for water.

7. No overnight parking in Day Parking areas.
