Entry Fees

First entry is \$23.00 per day; additional entries of same dog, same day are \$13.00. Junior Handler entries are \$10.00 per class. <u>Please make checks payable to GSSSC</u>. Entry fees include AKC recording fee of \$3.50 first entry/\$3.00 additional entry. Catalogs may be preordered for \$10 on the entry form. A limited number will be available at the trial for \$15.

If written notification is provided to the Trial Secretary <u>prior to the beginning of judging for the day</u>, a full refund of entry fees will be given for any bitch that comes into season, and a refund of entry fees, less \$6.00 per run for AKC fees and judging fees, will be given for any dog or handler that is injured or ill.

ONLINE ENTRIES

Online entries are available for these trials through AKC's Online Entry service. Go to the AKC Agility Online Entry Services page at www.akc.org/AgilityEntry and follow instructions there. During the first 48 hours after opening, the initial limit of entries per day designated as either online or paper will be as follows:

For each trial, **100** runs/trial via online entries, **250** runs/trial via paper entries. If either form of entry has not filled at the end of the 48 hour time period, the club reserves the right to decrease or increase either one accordingly.

Dogs Eligible to Enter

This trial is open to all dogs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or AKC Canine Partners listing number, or approved Foundation Stock Service (FSS) breeds. Bitches in season, aggressive dogs, blind or deaf dogs, or dogs suffering from any deformity, injury or illness which may affect the dog's physical or mental performance are ineligible to participate.

Mixed breed dogs that have been listed with AKC Canine Partners may participate, provided their listing number has been recorded on the entry form. *Please designate the dog's breed as "All American" on the entry form.*

Important Information for Exhibitors -- PLEASE READ!

Conditional, unsigned, incomplete, illegible, telephone, fax, e-mail or telegraph entries cannot be accepted. Entries not on official AKC forms, or photocopies of AKC forms without the agreement and rules on the reverse side of the official AKC entry form, are not acceptable. Returned checks do not constitute a valid entry.

A complete set of rules is available from the American Kennel Club, 8051 Arco Corporate Drive, Suite 100, Raleigh, NC 27617-3390, or from www.akc.org. It is the exhibitor's responsibility to enter their dog in the correct class. The Trial Secretary cannot make any changes (except for move-ups as a result of completing a title, and correction of specific errors as provided in the *Regulations for Agility Trials, Chapter 1, Section 21*) after the closing date of the trial. Be sure to check your entry form carefully and make certain you have entered the correct class(es). Please contact the Trial Secretary if you have guestions!

Entries sent by express mailing services MUST have the delivery signature requirement waived; otherwise receipt may be delayed. Entries will not be considered as being received until they are delivered to the address given on the entry form. Please note the opening date of September 8, 2021; no entries will be accepted before that date. Entries for a maximum of ten (10) dogs are allowed in one envelope; envelopes containing entries for more than ten dogs will be considered invalid, and will be returned to the sender. No hand delivered entries can be accepted until 8:00 AM on September 9, 2021.

GSSC is using a wait list to fill openings created by withdrawn entries after the trial's closing date/time. A maximum of 25 entries (runs) will be placed on each trial's wait list. All entries must have been received by the Trial Secretary prior to Friday, October 15, 2021 at 6:00 PM. Any entries withdrawn, with notification to the Trial Secretary in writing (e-mail OK) by 6:00 PM on Monday, October 25, 2021 will be replaced by a wait listed entry, if any are available. If a withdrawn entry is replaced by a wait listed entry, a full refund will be issued for the withdrawn entry; otherwise no refund will be given for withdrawn entries, except as specified above. Any wait listed entry that does not get into the trial will receive a full refund.

Entry fees will not be refunded in the event of errors or cancellation of entries after the published closing date, or in the event a dog is absent (other than as specified on page 2), disqualified, excused by the Veterinarian or Judge, or barred from competition by the Show Committee. No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.

Confirmation of entry and judging schedule will be e-mailed (or sent by postal mail to the address on the official AKC entry form, if no e-mail is provided) after the closing date; if not received at least 7 days prior to the show, contact the Trial Secretary. *Acknowledgment of receipt of entries prior to closing will be provided if the exhibitor provides a valid e-mail address on the entry form, or includes a stamped, self-addressed postcard with entry.*

Security personnel will be present at the trial site. However, Greater Spokane Shetland Sheepdog Club assumes no responsibility for any loss, damage or injury sustained by exhibitors, handlers, or spectators, or to any of their dogs or property, and further assumes no responsibility for injury to any child not under the control of his or her parents or guardians.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Show Committee, be asked to leave the show site and no refund of any fees paid will be made.

All dogs must be on leash at all times except when in the ring or designated warm-up area.

THIS CLUB DOES NOT AGREE TO ARBITRATE CLAIMS AS SET FORTH ON THE OFFICIAL AKC ENTRY FORM FOR THIS EVENT.

Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

The safety of dogs is of primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.

24C"		Dogs may be entered at this height at owner's discretion.

In the Regular classes, handlers may choose to run in a higher height division (20" dogs may be entered in 24C, but NOT in 24"). Dogs may not run in a division lower than their proper height division. In the Preferred classes, dogs may NOT run in a higher height division than that determined by their withers height.

The entry form has a box at the top of the form to check if the dog needs to be measured. Please check this box if appropriate, so that the Trial Secretary knows to include your dog on the *Dogs To Be Measured List*. It is no longer required that you submit a copy of your dog's jump height card with your entry form or show it during day of show check-in, but it is still the exhibitor's responsibility to have their original, official jump height card or temporary jump height form at each trial to present upon request. Additionally, if a measurement is necessary, it is the exhibitor's responsibility to have their dog measured prior to running. *Regulations for Agility Trials, Chapter 2. Section 4.*

Our judge, Susan Leitner, is not a VMO, so dogs will not be measured at these trials, UNLESS an AKC representative is present. If you have had one official measurement, your jump height is based on that measurement; if you have had two measurements that put your dog in different jump heights, you must use the most RECENT measurement to determine your dog's jump height. If your dog has not yet received an official measurement, use your estimate of the dog's withers height to determine your dog's jump height, according to the table above.

Move-Up and Class Change Information

Dogs may be moved up to a higher class at the request of the handler, as a result of completing an agility title at an earlier event, provided that the request is made to the Trial Secretary, in writing (e-mail is acceptable), by 6:00 PM on **Monday, October 25, 2021**. If a dog finishes a title during the trial, the handler may move up for the following days by filling out a move-up form (available at the event) and turning it in to the Trial Secretary within 30 minutes of the end of judging for the day.

The Regulations now allow exhibitors who have entered a class for which the dog or handler is not eligible to change their entry to the class for which they are eligible, but the request for such a change <u>must be in writing</u> and <u>must be submitted to the Trial Secretary at least 30 minutes</u> prior to the start of the Trial.

Judging

Judging starts at 8:00 AM all three days. Judge's briefing and course walk-through will take place prior to that time, as specified in the judging schedule.

Expected Order of Classes

Any changes to this order will be specified in the Judging Schedule.

Small to Tall on Friday and Sunday, Tall to Small on Saturday.

Friday: FAST (all levels), Standard (Excellent/Master, Open, Novice), JWW (Excellent/Master, Open, Novice)

Saturday: T2B, JWW (Excellent/Master, Open, Novice), Standard (Premier, Excellent/Master, Open, Novice)

Sunday: Standard (Excellent/Master, Open, Novice), JWW (Premier, Excellent/Master, Open, Novice)

Site Information

These Agility Trials will be held indoors on dirt. Ring 1 is 80' x115'; Ring 2 is 95' x 100'. The rings will be fenced with a combination of wood panels and portable fencing, with gates on the ends facing the center alley. Restroom facilities are on site. Crating will be indoors on concrete. Of course, we know everyone will uphold the *great reputation of agility exhibitors* by cleaning up after your dogs!

Equipment

Obstacles used will meet the specifications given in the current AKC regulations. Contact obstacles have rubberized surfaces. Electronic timers will be used.

Refreshments

We will not be providing lunch, snacks or drinks at these trials due to public health concerns. Exhibitors should plan to bring their own food and water. There are fast food establishments on Sprague Ave, south of the Fairgrounds.

Vendor Information

Unfortunately, due to space limitations, we are not able to accommodate vendor setups at these trials.

Awards

A qualifying score is required for all awards. All awards must be claimed at the show; none will be mailed.

Ribbons will be awarded to 1st through 4th place in each height division in each Regular and each Preferred class. Green ribbons will be awarded to all dogs receiving qualifying scores. New Title rosettes will be available for those completing a new title.

A Rosette and jump bar will be awarded to any dog completing a MACH or PACH at these trials.

*** If you think that you may complete a MACH or PACH at these trials, please let the trial secretary know ahead of time, so that we can plan to celebrate with you! ***

NEW INFORMATION: Class Changes Effective January 1, 2020

Entering a Mixture of Regular and Preferred Classes Within the Same Trial Weekend – Multiple Jump Heights Within the Same Trial Day

Effective January 1, 2020, exhibitors may enter a mixture of both Regular and Preferred classes on the same trial day and/or during a trial weekend. For example, the same dog may now be entered in Regular FAST and/or T2B to finish up those titles while also entered in Preferred Master STD/JWW to start working towards their PACH at the lower height. Any mixture of Regular and Preferred classes is allowed.

Please note that if a dog qualifies in Regular Master Standard and Preferred Master JWW (or vice versa) on the same trial day, then NO Double Q shall be earned toward either the MACH or PACH title. The Double Q still requires that Standard Agility and Jumpers With Weaves be either both Regular OR both Preferred on the same trial day.

Additionally, within the same Regular or Preferred classes, a dog may now be entered in multiple jump heights [in different classes] within the same trial day. For example, the same dog may now be entered in 20-inch Master STD/JWW while also entered in 24C-inch Premier STD/JWW on the same trial day.

A separate entry form must be submitted when the same dog is being entered in a mixture of Regular and Preferred classes and/or different jump heights within the same trial weekend, thereby clearly indicating which class(es) and/or jump heights belong together for each trial day of the weekend. [EXAMPLE: if you are entering a dog in some Regular classes and some Preferred classes, submit one entry form for the Regular classes, and another entry form for the Preferred classes.]

When calculating entry fees, treat multiple entry forms for the same dog as if only one form had been filled out. In other words, the 1st run entry fee is only paid once per day, per dog, even if that dog's runs have been submitted on multiple entry forms.

Entering For Exhibition Only (FEO)

As of January 1, 2020, For Exhibition Only may be offered at the option of the host club. FEO allows exhibitors to work with their dogs in a trial environment. <u>FEO is only allowed in the Time 2 Beat and FAST classes</u>. FEO will be of value to new exhibitors or exhibitors that are having difficulty with a specific obstacle and/or ring environment. Competitors must enter in T2B and/or FAST. Participation in FEO is non-qualifying.

- FEO runs are treated as trial entries. The exhibitor must enter the class(es) (T2B and/or FAST) prior to the closing date, pay class entry fee(s) and the Trial Secretary must record the entry in the Trial Catalog as part of the results for that class. FEO does not need to be noted on the entry form; the handler will declare the day of the show.
- Dogs may be entered in any jump height for FEO runs. <u>If entered in an ineligible jump height, the team is committed to FEO for that run</u> and must declare FEO on the start line. Day of show jump height changes are not allowed.
- Dogs may be entered in any level of FAST (Novice, Open, Excellent, Master). <u>If</u>
 the dog is not eligible for the level entered, the team is committed to FEO for that
 <u>run</u> and must declare FEO on the start line. <u>Day of show level changes are not</u>
 allowed.
- The exhibitor must declare FEO in the ring prior to leading out. FEO may be declared earlier (ex. when checking in at the gate board).
- Toys are allowed in the ring
 - Toys must be non-audible
 - o Toys may not leave the handler's hand
 - Toys that roll freely cannot be used
- Food/treats are not allowed in the ring
- FEO should be utilized for the benefit of the dog and not as a punitive correction.

 Harsh verbal and /or physical corrections shall not be tolerated. Any determination of harshness by the judge shall be immediately whistled and the handler will be dismissed from the ring.
- A judge must monitor the entire run. Judges can stop a run at any time.

Fix and Go On (FNG)

FNG allows exhibitors to immediately reattempt an obstacle at any time while on course when the dog's performance of an obstacle is not to their expectation. This allows the dog to successfully complete the obstacle then finish the course or leave the ring on a positive note. Using FNG will result in a non-qualifying score.

Fix and Go On is not pre-entered; rather, it occurs during the course of the run.

COVID INFO/WAIVER

Please note the waiver statement below. Because the COVID situation is constantly changing, we will update exhibitors on changes to procedures or requirements (such as mask requirements) prior to the trials based on whatever state and local policies are in effect at the time.

An inherent risk of exposure to COVID-19 exists in any public place where people are present. COVID-19 is an extremely contagious disease that can lead to severe illness and death. By attending these events, you voluntarily assume all risks related to exposure to COVID-19.

Workers will receive a coupon for each class they work; coupons can be used toward future entries in any GSSSC event.

Directions to Show

Coming from the west (Seattle/Spokane), take I-90 to the Freya exit (#283B) which merges with 3rd Avenue. Continue on 3rd to Havana St. Turn LEFT on Havana, and go 0.7 mile, crossing Sprague Avenue (traffic light) and continuing past the main Fairgrounds entrance to Broadway. Turn RIGHT on Broadway, go 0.5 mile and turn RIGHT into the Fairgrounds at Gate R.

Coming from the east (Idaho/Montana), take I-90 to the Broadway exit (#286) and turn RIGHT off the exit ramp onto Broadway. Continue for 1.0 mile on Broadway, crossing Fancher (traffic light), and then turn LEFT into the Fairgrounds at Gate R.

INSTRUCTIONS

Handlers may opt to enter in a higher **height division** for all **Regular** titling classes, but not in a division lower than their proper height division. Dogs entered in the **Preferred** classes <u>must</u> compete at the required jump height and <u>may not</u> compete in a jump height division <u>higher or lower</u> than their proper height division.

All dogs that have not been officially measured for an **Agility Jump Height Card** may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, that measurement will be valid for this trial *or back-to-back trials* only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

Dogs listed in the AKC Canine Partners SM program may be eligible to enter all-breed AKC agility trials at the club's option. These dogs should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.

Junior Handlers should enter their Junior Handler number on the front of this form. Should you not have your Junior Handler number, it may be obtained from the American Kennel Club (919) 233-9767. If the Junior Handler is not the owner of the dog identified on the face of this form, what is the relationship of the Junior Handler to the Owner?
